The Regulation of King Mongkut's University of Technology North Bangkok Fees and Tuition Fees for the Vocational Certificate and Bachelor's Degree Programs, 2009 (B.E. 2552)

An improved and updated version of the Regulation of King Mongkut's University of Technology North Bangkok concerning the fees and tuition fees for the Vocational Certificate and Bachelor's Degree, 2009 is hereby drafted to efficiently support the academic management of the university.

Based on the 2007 Act of King Mongkut's University of Technology North Bangkok, Article 22(2) and (15), along with the resolution of the Council of King Mongkut's University of Technology North Bangkok (5/2009) on 7th October 2009, the Regulation of King Mongkut's University of Technology North Bangkok concerning the Fees and Tuition Fees for the Vocational Certificate and Bachelor's Degree Programs, 2009 were drafted as follows:

Item 1 The regulation is hereby entitled "The Regulation of King Mongkut's University of Technology North Bangkok Concerning the Fees and Tuition Fees for the Vocational Certificate and Bachelor's Degree Programs, 2009."

Item 2 The regulation is to be effective for new students enrolled in Semester 1/2010 onward. Students admitted before academic year 2010 are to pay fees according to the Regulation of King Mongkut's University of Technology North Bangkok concerning the Fees and Tuition Fees for the Vocational Certificate and Bachelor's Degree Programs, 2008 (B.E. 2551), and according to any revised versions concerning this regulation until graduation.

Item 3 To be discontinued from here onwards are the Regulations of King Mongkut's University of Technology North Bangkok Concerning the Fees and Tuition Fees for the Vocational Certificate and Bachelor's Degree Programs, 2008 and any revised versions concerning this regulation.

Item 4 In this regulation,

"University" means King Mongkut's University of Technology North Bangkok.

"The president" means the president of King Mongkut's University of Technology North Bangkok.

"Students" means the students admitted to the Vocational Certificate program of the College of Industrial Technology and to the bachelor degree programs in King Mongkut's University of Technology North Bangkok.

Item 5 This regulation is overseen by the president of King Mongkut's University of Technology North Bangkok, who has the right to issue notices concerning their implementation. The president also has the right to make final decisions pertaining to any problems in the decision-making or interpretation of this regulation.

Should there be a case of a fee for an item in this regulation that is not applicable, the case is to be presented to the Finance and Property Committee for approval, prior to the drafting of any additional regulation by the institution.

Item 10 Educational fees will be charged as follows:

a. Tuition fees of regular student in bachelor degree is a package, 19,000 baht per semester (King Mongkut's University of Technology North Bangkok Council's resolution 9th/2014 No.15, on 26th November 2014 (B.E.2557)

b. Special student 29,000 Baht/semester

In case a student has complete the number of semesters required by the curriculum but has not complete all course that are required for graduation, the student will be charged 5,000 Baht per semester.

Section 4 Payment and Repayment

Item 11 Students are required to pay all fees and educational fees within the time designated by the university. Fees are not refundable EXCEPT:

1. The property insurance fee, issue 7(2), will be refunded to graduates after the deduction of any debts. In case a student does not file for reimbursement within 6 months from the termination of his/her student status, the property damage insurance will be deemed as the institution's income.

2. Students are the University scholarship recipients.
