## The Regulation of King Mongkut's University of Technology North Bangkok Concerning Fees and Educational Fees for the English Enhancement Undergraduate Program of the Faculty of Engineering, 2012 (B.E. 2555)

For the efficacy of the University's budget and financial administration, the regulation concerning the educational fees for the English enhancement undergraduate program of the Faculty of Engineering was devised.

Based on the 2007 (B.E. 2550) Act of King Mongkut's University of Technology North Bangkok, Article 22(2); University regulation on Financial, Budget and Property Issues 2008 (B.E. 2551), item 8.4; along with the resolution of the council of King Mongkut's University of Technology North Bangkok from the meeting no. 1/2012 held on 25th January 2012, a draft of the regulation of King Mongkut's University of Technology North Bangkok concerning the educational fees for the English enhancement undergraduate program of the Faculty of Engineering, 2012 was devised.

Item 1 The regulation is hereby entitled "the regulation of King Mongkut's University of Technology North Bangkok Concerning the Fees and Educational Fees for the English enhancement undergraduate program of the Faculty of Engineering 2012."

Item 2 This regulation is to be active to new students enrolling in semester 1/2012 (B.E. 2555) onward. Item 3 In this regulation,

- "University" refers to King Mongkut's University of Technology North Bangkok.
- "President" refers to the president of King Mongkut's University of Technology North Bangkok
- "English enhancement instruction" refers to the course in which a minimum of 20 percent of the total course credits are conducted in English language.
- "Students" refers to the students admitted to the above program under Faculty of Engineering, King Mongkut's University of Technology North Bangkok.

"The property damage insurance" refers to money collected only once at the admission of the new student in accordance with item 7(12) of the Regulation of King Mongkut's University of Technology North Bangkok Concerning Fees and Educational Fees for Vocational Certificate and Undergraduate Programs, 2009.

Item 4 The institution is to charge general fees from students based on the designated rates from general fees in the University's Regulation concerning the Fees and Educational Fees for Vocational Certificate and Undergraduate Programs.

Item 5 The institution is to charge for educational fees from students as follows:

- (1) The educational fees for regular semester is 21,500 baht.
  - The Regulation of King Mongkut's University of Technology North Bangkok Concerning Fees and Educational Fees for the English Enhancement Undergraduate Program of the Faculty of Engineering, (Revision 2) 2011 (B.E. 2554)

In case a student has studied up to the number of semester designated by the program but still has not been enrolled in all the courses as required by the program, the student is to be charged 5,000 baht per semester.

- (2) The educational fees for summer semester is 3,000 baht.
- (3) The fees for internship registration for summer semester is 3,000 baht.
- (4) The fees for maintaining student status in case the student has not completed the program and has not been enrolled in courses as required by the program is 500 baht per semester.
- (5) The fees for maintaining special project or thesis in a regular semester or summer semester is 3,000 baht per semester.

Item 6 Students are to pay for the fees and educational fees within the deadline designated by the institution. Reimbursement may be done in the following cases:

- (1) The property damage insurance will be returned to the student after the termination of his/her student status and after deduction has been taken for any debts. In case a student does not file for reimbursement after 6 months from the termination of his/her student status, the property damage insurance is to become the institution's income.
- (4) In the case of the student whose payment for general fees and educational fees has been waived by the institution based on the notice of scholarship granted by the institution.

Item 7 Students admitted before the academic year 2012 are to be charged for fees and educational fees according to the Regulation Concerning the Fees and Educational Fees for Vocational Certificate and Undergraduate programs.

Item 8 This regulation is overseen by the president of King Mongkut's University of Technology North Bangkok, who has the right to issue rules in accordance with this regulation. The president is entitled to the right to make the final decision pertaining to any problems in the decision-making or interpreting of this regulation.
