The Regulation of King Mongkut's University of Technology North Bangkok Concerning Tuition Fees for Graduate Programs, 2012 (B.E. 2555)

It is deemed timely to review and propose regulation amendments for King Mongkut's University of Technology North Bangkok's Regulation concerning Tuition Fees for Graduate Programs, 2008 (B.E. 2551) in support of effective and efficient implementation.

According to Articles 22(2) and (14) of the Act of King Mongkut's University of Technology North Bangkok 2007; the resolution from Financial and Property committee in the meeting no. 9/2555 held on August 20, 2012; along with the University Council's resolution from meeting no. 7/2555 held on September 12, 2012, the regulation is declared as follows:

Item 1 This regulation is called "King Mongkut's University of Technology North Bangkok's Regulation concerning Tuition Fees for Graduate Programs, 2012 (B.E. 2555)".

Item 2 This regulation takes effect to students enrolled in the first semester of academic year 2013 onward.

Item 3 The regulation of King Mongkut's University of Technology North concerning educational fees for graduate programs 2008 (B.E. 2551) is revoked. This regulation shall supersede and nullify the validity of the earlier contradictory regulations, orders, resolutions or notices.

Item 4 According to this regulation, "the president" refers to the president of King Mongkut's University of Technology North Bangkok.

Item 5 Based on currently approved amounts, the tuition, fees, and charges for the graduate programs will correspond to the period of study time as specified in the program of each faculty, as found in the attachment.

The 2008 university regulation on educational fees and other fees for all graduates student remains valid for those enrolled in the university before the first semester of 2013 (1/2556).

Item 6 The president oversee the regulation and has right and authority to use his own discretion and judgment should there be any doubts or disagreement about the interpretation.
