King Mongkut's University of Technology North Bangkok Announcement of University Housing Rates and Fees, Prachinburi Campus, 2013 (B.E.2556)

It is deemed timely and appropriate to revise the official Announcement of King Mongkut's Institute of Technology North Bangkok on housing charges and fees, of Prachinburi Campus issued on 1 December 2003 (B.E. 2546) and its additional amendments.

By virtue of item 9 of King Mongkut's University of Technology North Bangkok Regulation on the University Housing 2012 along with the resolution of the Committee of Finance and Property in the meeting no.5/2013 on 20 May 2013, the Announcement of University Housing Rates and Fees pertaining to the Prachinburi campus issued on 1 December 2003 (B.E.2546) and amended versions are nullified. The new rates, as approved, will apply from academic year 2013 onward.

Item 1 In this announcement:

"Student Dormitory" means the student dormitory of King Mongkut's University of Technology North Bangkok, Prachinburi Campus.

"Semester" means each semester and summer session

Item 2 Student Dormitory fee is paid once a semester as follows:

- (1) For the first semester, it is paid on the date of resident application or as promulgated by the Committee of Student Dormitory Announcement.
 - (2) For the following semesters, it is paid as endorsed by the Committee of Student Dormitory Announcement. Item 3 The following housing charges and fees are required:
 - (1) Students

(1) Stadelits	
A. Regular semester	
1. A room for 4-5 persons	3,600 baht/ person/ semester
2. A room for 3 persons	4,600 baht/ person/ semester.
B. Summer semester (the fee is paid monthly)	
1. A room for 4-5 persons	900 baht/ person/ month
2. A room for 3 persons	1,150 baht/ person/ month
C. Property damage insurance	1,000 baht/ person/ semester
D. A deposit of room and wardrobe keys	100 baht/ person/ semester
(2) Staff and non-staff	
A. University staff	
1 Dagular room	100 bobt/ day

1. Regular room 100 baht/day 2. Air-conditioned room 200 baht/ day B. Non-staff

1. Regular room 300 baht/day 2. Air-conditioned room 500 baht/day

(3) Internal and external students

A. An internal student 40 baht/day B. An external student 60 baht/day

Item 4 Electricity bill is charged according to meter reading of each room with charge of 4 baht per unit. Students must pay the electricity bill every month as specified in Student Dormitory Announcement, at the Dormitory Administration Unit. The dormitory staff is responsible for recording the data of meter reading.

Item 5 Fines

- (1) Late payment of the electricity bill is fined 100 baht a month.
- (2) Late payment of Student Dormitory fee is fined 200 baht at a time.
- (3) In a case where students forget their room key, they must be fined 50 baht at a borrow-and-return time.

Item 6 The refund of property damage insurance as in item 3(1) will be delivered in full amount or in the net balance after deduction of property losses and damages. The refund will be delivered to students upon leaving and returning the dorm key to the staff.

Item 7 The university reserves the right to allocate rooms to those completing all payment requirements in item 2. The priority and fair allocation of campus accommodation is subject to the University's policy and consideration. The decision of the Student Dormitory Committee is considered final.

Item 8 In the event of disagreement or any discrepancies in the interpretation, the president's decision shall prevail. The enforcement begins the academic year 2013 onwards.
